# **Peer Reviewed Publication Categories**

# **Regular Article**

This section is for completed research. Inclusive of all topics. Authors are typically university faculty members or graduate students. Double-blind peer-reviewed.

#### Criteria:

- 30 pages maximum (inclusive of tables, graphs, and references)
- Word doc file, Times New Roman, 12 font, single spaced
- Normal margins on letter size pages
- All tables, graphs, or photos must be on their own individual page at the end of the article
- APA 6th edition publication formatting

#### **Research-In-Motion**

This is for research that is currently being undertaken or are reporting on initial findings of a longitudinal study/program. Authors are typically university faculty members or graduate students. Double-blind peer-reviewed.

#### Criteria:

- 15 pages maximum (inclusive of tables, graphs, and references)
- Word doc file, Times New Roman, 12 font, single spaced
- Normal margins on letter size pages
- All tables & graphs must be on their own individual page at the end of the article
- APA 6th edition publication formatting

#### **Graduate Student Research Briefs**

This is a brief synapses of graduate research that is either about to start, currently being undertaken, or reporting on final work. Restricted to graduate student research. A graduate student must be first author. Double-blind peer-reviewed. This is an option for students to report on their findings but cannot write a full article.

#### Criteria:

- 5 pages maximum (inclusive of tables, graphs, and references)
- Word doc file, Times New Roman, 12 font, single spaced
- Normal margins on letter size pages
- Each tables & graphs must be on their own individual page at the end of the article
- APA 6th edition publication formatting

# **Non-Peer Reviewed Publication Categories**

#### **Academic Book Reviews**

Reviews of academic level career books that would be of interest to faculty and students. Topic must be on career development. Review author must provide their credentials and expertise on the books topic to the journals editorial staff. Submission of a book review does not guaranteed publication. Final decision on publication will be made by the Editorial Board.

#### **Non-Academic Book Reviews**

Reviews of career and career development books that would be of interest to the career practitioners. Review author must provide their credentials and expertise on the books topic to journals editorial staff. Submission of a book review does not guaranteed publication. Final decision on publication will be made by the Editorial Board.

#### Criteria for Book Reviews:

- 2-4 pages maximum.
- Word document, Times New Roman, 12 font.
- Reviewers cannot be one of the book authors.
- Reviewers must not be paid for the review by the book authors or publisher.

# **Practitioners & Community Best Practices**

This is for articles on best practices, new techniques, new programs, and program results from community career practitioners. Articles can be written by career practitioners and counsellors. Authors in faculty positions with ethics approval research are required to publish under the peer-reviewed categories.

Submission of a practitioners & community best practices article does not guaranteed publication. Final decision on publication will be made by the Editorial Board.

#### Criteria:

- 10 pages maximum
- Word document file
- Times New Roman, 12 font, single spaced
- Normal margins on letter size pages.
- All tables, graphs, or photos must be on their own individual page at the end of the article.
